

# Privacy Policy

## Introduction

Rangers International Football Club ("Rangers FC", "we", "us", or "our") respects your privacy and is committed to protecting your personal data. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website <https://www.rangersintl.com> (the "Site"), purchase merchandise, buy tickets, subscribe to our newsletter, or otherwise interact with our services.

Please read this Privacy Policy carefully. By accessing or using our Site, you acknowledge that you have read, understood, and agree to be bound by this Privacy Policy. If you do not agree with our policies and practices, please do not use our Site.

## Information We Collect

### Personal Information You Provide

We may collect personal information that you voluntarily provide to us when you:

- **Purchase tickets or merchandise** through our online shop
- **Subscribe to our newsletter** to receive updates about Rangers FC
- **Create an account** on our website
- **Contact us** through our contact forms or email
- **Join our fan club** or foundation programs
- **Participate in surveys, contests, or promotions**

This information may include:

- Date of birth

- Any other information you choose to provide

### Information Collected Automatically

When you visit our Site, we may automatically collect certain information about your device and browsing actions, including:

- **Device Information:** IP address, browser type and version, operating system, device identifiers
- **Usage Data:** Pages visited, time and date of visits, time spent on pages, clickstream data, referring website addresses
- **Location Data:** General geographic location based on IP address
- **Cookies and Similar Technologies:** We use cookies, web beacons, and similar tracking technologies to enhance your experience (see our Cookie Policy section below)

## **Third-Party Information**

We may receive information about you from third parties, such as:

- Social media platforms (if you interact with our social media pages)
- Analytics providers
- Payment processing partners
- Marketing and advertising partners

## **How We Use Your Information**

We use the information we collect for various purposes, including to:

## Legal Basis for Processing (GDPR)

If you are located in the European Economic Area (EEA), United Kingdom, or other jurisdictions with similar data protection laws, we process your personal data based on the following legal grounds:

- **Consent:** When you have given explicit consent for specific processing activities (e.g., marketing communications)
- **Contract Performance:** To fulfill our contractual obligations when you purchase tickets or merchandise
- **Legitimate Interests:** For our legitimate business interests, such as improving our services, fraud prevention, and internal analytics
- **Legal Obligation:** To comply with applicable laws and regulations

## How We Share Your Information

We do not sell your personal information. We may share your information in the following circumstances:

### Service Providers

We engage trusted third-party service providers to perform functions on our behalf, including:

## Legal Requirements

We may disclose your information if required to do so by law or in response to:

- Valid legal processes (court orders, subpoenas, warrants)
- Requests from government authorities or law enforcement
- Protection of our rights, property, or safety, or that of our users or the public
- Investigation of fraud, security issues, or violations of our terms

## **Business Transfers**

If Rangers International FC is involved in a merger, acquisition, asset sale, or bankruptcy, your information may be transferred as part of that transaction. We will notify you of any such change and any choices you may have.

## **International Data Transfers**

Rangers International FC is based in Nigeria. If you are accessing our Site from outside Nigeria, please be aware that your information may be transferred to, stored, and processed in Nigeria or other countries where our service providers operate.

We take appropriate safeguards to ensure that your personal data remains protected in accordance with this Privacy Policy and applicable data protection laws, including implementing standard contractual clauses or other approved transfer mechanisms where required.

## **Data Retention**

We retain your personal information only for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law.

Retention periods vary depending on the type of information and purpose:

- **Transaction records:** Retained for accounting and tax purposes (typically 7 years)
- **Marketing communications:** Until you unsubscribe or withdraw consent
- **Account information:** Until you request account deletion or account remains inactive for an extended period
- **Website analytics:** Typically retained for 26 months

When we no longer need your personal information, we will securely delete or anonymize it.

## **Your Rights and Choices**

### **Access and Portability**

You have the right to request access to the personal information we hold about you and, in some cases, receive a copy in a portable format.

### **Correction**
